Resale guidelines for external sale

Due to Canada's export laws and the nature of highspeed cameras, one of our requirements is to know exactly who the end user of the Chronos is and we need to have their contact information on file in case we get audited by Canada customs.

We are required by customs to adhere to the following statement:

"Canadian exporters will provide fulsome and truthful declarations of the goods and the consignee. Furthermore, they will not knowingly cause or assist any shipment, transshipment, diversion or transfer of sensitive goods/technology to entities of concern."

From a criminal investigations perspective, the concept of willful blindness (ignorance of the law) and recklessness (deliberately or unjustifiably pursuing a course of action while consciously disregarding the risks from those actions) do not recuse a company or individual from their responsibilities.

If the CBSA were to detain a shipment from Kron Technologies, one of the mandatory documents is an end user statement. This must be filled out by the actual end user of the goods (not just the receiving party from Canada). The end use statement must explain where the goods will be used, and must also clearly state that the goods will not be used in a weapons of mass destruction program.

Another point to take into consideration is proliferators will often attempt to acquire goods that fall below the regulatory thresholds. If we look at electronic streak cameras (for example), the control language explains that those having a temporal resolution better than 50ns are controlled, and therefore would require a permit from Global Affairs Canada in order to be lawfully exported from Canada. A proliferator (state-sponsored or rogue agent) will attempt to acquire these items that have a threshold just under the requirement. Perhaps the quality will not be as good, however it may be "good enough" to get the desired job done. The Chronos cameras fall into the "good enough" category when it comes to the controlled and not controlled export list regarding high speed cameras.

Keeping in check with Canadian customs the reseller agrees that no shipment to the best of their knowledge will be sold to an individual, entity or corporation in the following countries:

- Iran
- North Korea
- Ukraine

There is no drop shipping. The cameras are purchased outright and paid in full before they will be sent to the reseller.

What we expect from the reseller:

- RMA tier 1 customer support (Material covered in the user manual)
 - Anything higher than this is referred back to Kron Technologies
- Completion of the attached form ("Statement by Ultimate Consignee and Purchaser") to be completed for each sale of the Chronos 1.4 and 2.1-HD failure to do so will result in immediate termination of the agreement.

Exclusive selling or distribution rights will not be given to any one person, corporation or entity for any region. This is strictly non-negotiable.

Pricing is as follows:

1-4 Cameras per month: Full price

5-9 Cameras per month: 5% discount

10-19 Cameras per month: 10% discount

20+ Cameras per month: 15% discount

Each camera comes with a 1 year included manufactures warranty. If the reseller wishes to purchase extended warranty from us it will be done at the time of initial sale for the full listed amount at krontech.ca. The warranty will be tied to the serial number of the camera.

Warranty pricing is as follows:

- 1 year included warranty: Included with purchase of camera
- 2 year extended warranty (3 years total): 349.00 USD (Chronos 1.4) / 440 USD (Chronos 2.1-HD)
- 3 year extended warranty (4 years total): 449.00 USD (Chronos 1.4) / 550 USD (Chronos 2.1-HD)

Extended warranty will not be discounted.

If there are any pricing discrepancies between this sheet and our website krontech.ca, krontech.ca will override any other listed pricing.
